1.0 CALL TO ORDER

Jennifer Knight called the Executive Session to order at 5:47 pm

In Accordance with ORS.192.660 (2) (b) – To consider the dismissal or disciplining of, or hear complaints or charges brought against a public officer, employee, staff member or individual agent who does not request an open hearing.”

2.0 EXECUTIVE SESSION

2.1 Consideration an Appeal Under Step 4 of KL-AR in Response to a Parent Complaint Against Staff members

The Board read the two complaints from Paige Winebarger against Rob Bonner and Jessica Mumm.

Jennifer Knight opened the meeting up for discussion on the two complaints.

Cheyenne Edgerly asked if there were other complaints filed against Rob Bonner or Jessica Mumm.

Joel Hoff shared there are other athletic complaints.

Cheyenne asked if any of the other complaints are against Rob Bonner.

Joel Hoff shared they were complaints about athletic events. They are not directly against Rob Bonner.

Jessica Brumble asked what would be determined in this meeting.

Melissa Skinner explained that the Board would be deciding if they want to hear this complaint.

Jessica Brumble shared that she did not know why Rob Hess put all of them in one report.

Cheyenne Edgerly shared that there is not an objective eye on this. Cheyenne Edgerly said that there have been several complaints against Rob Bonner.

Melissa Skinner shared that we have spent approximately \$15,000.00 to outside individuals on this complaint.

Cheyenne Edgerly asked who received the end of the year surveys.

Melissa Skinner shared that these surveys are now being forwarded to her and she will be reviewing them.

Joel Hoff shared that Rob Bonner reviews the surveys with the coaches at the end of the season.

Steve Holiday asked if complaints are filed in the personnel file.

Jay Weeks shared that the report was attached to the evaluation and added to the personnel file.

Scott Cooper shared that he does not support hearing the complaint.

Steve Holliday shared that he agreed.

Cheyenne Edgerly shared that she does not want to take Melinda's advice.

Justin Alderman asked if the employees were given written notice of the meeting and given the option for a public hearing per OAR 199-040-0030.

Joel Hoff said he would follow up on this.
