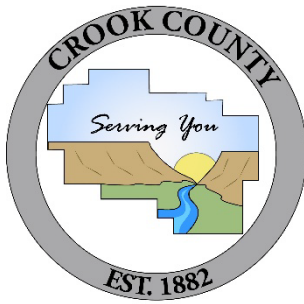

Notice of Public Hearing

Notice is hereby given that a Crook County Hearings Officer will hold a public hearing at **4:00 PM** on **Wednesday, July 29, 2026**, to consider the following:

Record number 217-26-000166-PLNG – Consideration of Initiating Revocation/Modification Proceedings of Conditional Use for aggregate mining. Record numbers 217-15-000115-PLNG (Conditional Use) and 217-18-000347-PLNG (Modification of Conditional Use), located at 4755 NW Stahancyk Ln and identified by the taxlot numbers 1415140000702 and 1415140000703; record number 217-21-000573-PLNG (Planning Commission Decision Conditional Use) and 217-22-000540-PLNG (County Court Final Decision Conditional Use), located at 6487 NW Lamonta Rd and identified by the taxlot number 1415140000103.

The hearing is subject to the following criteria: Crook County Code, Title 18, Chapter 18.172.070, 18.144.070, and 18.172.100.

A notice of public hearing is being mailed to all affected property owners, and to the appropriate entities and public agencies at least 20 days prior to the hearing.

Written testimony or comments may be submitted to the Crook County Community Development Department by email at plan@crookcountyor.gov and may also be submitted in person or by mail to 300 NE 3rd St, Room 12, Prineville, OR 97754. Written testimony of proponents received by Wednesday, July 1, 2026, and written response of the Permittee received by July 15, 2026, will be considered by staff prior to the issuance of the staff report and recommendation on this application. However, written testimony will continue to be accepted until the record closes, which may occur as soon as the conclusion of the public hearing.

Failure to raise an issue in the hearing, in person or by letter, or failure to provide sufficient specificity to afford the decision maker an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals based on that issue.
